

Presbytery Meeting Highlights

November 19, 2016 First Presbyterian Church Tuckerton

Tuesday evening's meeting began early, well before 4:00 p.m. in the lower level of Belmar's church, in a flurry of activity. The registration desk and Genesis Center tables were surrounded by Pastors, commissioners and visitors, all checking in, perusing resources, and conversing with one another.



Rev. Gary Filson, Monmouth's moderator, was soon up in front of the sanctuary, a floor above, precisely at 4:00 p.m. where he began the meeting. After a couple of announcements, most were seated in the sanctuary as the meeting got under way.

The full docket began with a presentation by Ruling Elder Walt Vincent. He gave a report on the work of the Protestant campus ministry of Rutgers University and encouraged congregations to continue supporting this ecumenical organization.

Next, Mr. Vincent, along with Rev. John Monroe and the Rev. Merideth Mueller, reported on their time spent at the General Assembly this past summer in Portland, Oregon. Each spoke of their respective committee work, their awe at the sheer number of people in attendance, and the honor of representing Monmouth Presbytery.

Rev. Bill Walker of Sykesville, and Myrlene Hamilton Hess of Bayville were recognized for their respective retirements and ministries. Rev. Wendy Bailey led the Presbytery in a liturgy, followed by Rev. Merideth Mueller and the Rev. Christina Hindley, each took a moment to express gratitude for the positive role Ms. Hamilton Hess played in their individual ministries. The Rev. Suzanne Schafer-Coates acknowledged Rev. William Walker for his ministry at Sykesville Presbyterian church. She also noted his involvement at ground zero in New York after the 9/11 attacks.

After the dinner break, the Presbytery gathered for worship, led by some of the members of the Presbytery's Youth

Triennium Delegation followed by a report by those that had attended.

At the end of worship, Rev. Bill Morris introduced 10-year-old Meghan DeLuca, a fifth grade student who delivered the ministry minute. After observing a homeless man in Washington D.C. while on vacation with her family a couple of years ago, Meghan was moved to do something about the plight of the homeless. She began fundraising for Cardboard Box City, an advocacy and awareness project under the umbrella organization Family Promise of Monmouth County. Rev. Gary Filson took to the floor to commission two of the Synod Commissioners, Rev. Carl Wilton and Elder Sue Smith.
